


## **Money Services Businesses Fact Sheet**

## **States Using NMLS**

As of September 30, 2018, 41 states, the District of Columbia, and Puerto Rico are managing Money Services Businesses (MSB) licenses on NMLS.



The financial services categorized as MSB activities in NMLS include: money transmission, check cashing, issuing or selling travelers checks, issuing or selling drafts, foreign currency dealing and exchange, issuing or selling money orders, bill paying, transporting currency, and issuing or selling prepaid access/stored value products.

There are 2,284 companies in NMLS that hold a total of 6,599 approved MSB licenses. The following table lists the number of approved MSB company licenses by state regulatory agency.



## **Money Transmitters and Authorized Agents**

NMLS has recently deployed functionality to allow Money Transmitters to upload lists of their authorized agents to state regulators. As of September 30, 2018, 39 states, the District of Columbia, and Puerto Rico have instructed their Money Transmitters to use the Uniform Authorized Agent Reporting (UAAR) functionality.

## **Money Transmitters in NMLS:**

- Companies: 399
- Total state licenses held: 4,592
- 60% of the companies are licensed in more than one state
- 130 companies are licensed in more than 10 states
- 194 companies are currently reporting 435,071 Active Authorized Agent relationships in NMLS, and 205 companies are reporting no agents used
- NMLS contains 287,345 Active Agent Locations, with 82,820 used by multiple principals
- 13 companies have uploaded over 5,000 agents
